Push Polls

With the 2022 Florida campaigns in full swing, the effort to steal or subvert the vote has begun in earnest. I received an unsolicited text purporting to be from some “Florida Survey Organization” that was seeking to collect survey data related to the gubernatorial and senatorial campaigns. This looked remarkably similar to fake surveys I received from State Rep Mike Caruso’s campaign and Tracy Caruso’s failed mayoral campaign and I was right. Voters and election officials must be aware of these fake surveys, as they are designed to misinform, mislead, and dissuade voters from supporting democratic candidates.

The surveys ask a few general questions about whom you voted for and whether you have positive or negative views of specific candidates or elected officials. They then go on to provide what they claim is a statement of fact and ask if that fact makes you more or less likely to vote for the candidate. All the statements pertaining to candidates Charlie Crist and Val Demmings are either blatantly false or intentionally extremely misleading, baselessly asserting something extremely negative about the candidate. They then provide statements about Ron DeSantis and Marco Rubio, also blatantly false and misleading, but all of which are

Keep the Immigrants, Deport the Racists

America has always been a beacon for those fleeing poverty and persecution, as memorably described in Emma Lazarus’s poem, “The New Colossus,” with its iconic, aspirational closing lines:

Give me your tired, your poor
Your huddled masses yearning to breathe free,
The wretched refuse of your teeming shore.
Send these, the homeless, tempest-tost to me,
I lift my lamp beside the golden door!

As every schoolchild knows or should know, the entire poem is engraved on the Statute of Liberty and welcomed tens of millions of immigrants who made the hard journey from the Old to the New World. Too often (and most of all today) their descendants have forgotten and/or dishonored the pledge made to their forebears. There is a special place in hell for those who pull up the ladder after themselves.

It takes courage, drive, and spirit to leave the nation and community of your birth for a land where often you do not even speak the language. Immigrants have enriched America with their determination and vitality while the racists who attack them have both

debased themselves and diminished our country with their prejudice and ignorance.

A Brief History

This article addresses those who came to our shores of their own volition. It does not address those who were kidnapped and brought in chains to be sold as chattel or the unsurpassed contributions they and their descendants made to this country.

The treatment of immigrants has varied over time. Until the 1890s, the vast majority of immigrants came from Northern and Western Europe and were largely Protestant. Of the 25 million immigrants who landed at Ellis Island before World War I, a mere 1% were denied entry, mostly for health reasons.

In the late 1890s and early 1900s, the nationality and religion of the immigrants changed. The new arrivals, from Southern and Eastern Europe, were largely Catholic and Jewish and were subject to the same lies spewed about Latin Americans today.

positive messages. The negative statements about the Democratic candidates are designed to underhandedly influence voters to lower their opinion of these candidates based on the false information and dissuade them from voting for them or voting at all. The positive statements about the Republican candidates are designed to embellish opinions of these candidates, thus increasing votes for the Republican candidates.

Do these sound like bona fide surveys? Certainly not. They are illegitimate in every way, disguising what are blatant political hatchet jobs as voter surveys. They plant exclusively false negatives about Democratic candidates and exclusively false positives about the Republicans. Surveys ask questions, they do not intentionally plant one-sided, blatantly false information about candidates. It is critical for voters to watch for these surveys, and regardless of whether the voters choose to answer the questions, they must not fall victim to the dishonest messaging.

Some of the surveys arrive by email or text, but others are by phone call. The callers are usually not from the organizations behind the surveys, but rather dupes they hired to brainlessly and simply go through a list of questions and record the "yes or no" responses. When I get these folks on the phone, I keep trying to ask whether they are aware that the statements they are reading are false, who is sponsoring the surveys, and whether they realize they are engaging in dishonesty and election law violations. All I get in return is that the callers were just hired to sit in an office and ask the list of questions without deviation. I hope their mothers are proud that they are lying to voters and subverting the vote.

Mike Caruso used these tactics effectively against Jim Bonfiglio, constantly smearing him with such attacks in fake surveys. Tracy Caruso engaged in the same extreme dishonesty in her failed mayoral campaign, and came dangerously close to winning that election. The Carusos are obviously not alone and other Republican candidates use the same despicable tactics. Investigations into election law violations demonstrated that this is a right-wing effort wherein a political organization created layers of phony shell companies to hide their true identity and culpability in these schemes. They use this shell game to improperly solicit and donate money for campaigns such as Caruso's, to create and distribute dishonest, dangerous campaign mailings, and to hide their true identity.

The Carusos are all in for Ron DeSantis and the MAGA movement. Mike Caruso just appeared with DeSantis while the governor spewed his racist, extremist nonsense. Using this shell game system of phony companies, they and others attempt to hide their true support for and from the Republican extremist base. They pretend to have no part in such vile political opprobrium. Voters need to understand what is happening and reject this attempt to subvert their vote. Do not vote for campaigns that use these surveys. If they want to blatantly lie about their Democratic opponent, then do it under their own name instead of cowardly disgracing themselves hiding behind the shell companies. If candidates need to go to such lengths to hide their views and tactics, they cannot be trusted to serve the public interest.

In the forefront of the opposition was the Ku Klux Klan, which had reinvented itself as a **mainstream movement** and successfully lobbied Congress to pass the Immigration Act of 1924:

It included farmers, bankers, railroad workers, suffragists, ministers, mayors, and governors . . . They dressed their anti-immigrant, anti-Catholic, antisemitic message in patriotism and Christian righteousness . . . For many white Protestant Americans, the Ku Klux Klan was a respectable pastime for the whole family.

Crime: Immigrants actually pose less of a threat to our communities than U.S. born citizens. Legal immigrants commit *fewer* crimes than U.S.-born citizens, and undocumented immigrants commit *far fewer* crimes. US-born citizens are more than twice as likely to be arrested for violent crimes, 2.5 times more likely to be arrested for drug crimes, and over 4 times more likely to be arrested for property crimes.

Taxes: Immigrants paid more than \$492 billion in taxes in 2019, including more than \$30 billion paid by undocumented immigrants. Trump pays less taxes (and does more harm) than the average immigrant.

Today's immigrants differ from those who preceded them in the color of their skin, not the content of their character. Those who judge them on the former have no place in this great land.

The Act imposed severe quotas on immigration from Southern and Eastern Europe. Unlike today, however, there was virtually no enforcement infrastructure and those who came illegally faced little threat of removal.

Statutes of limitations protected those who entered illegally before the 1940s and tens of thousands of unauthorized immigrants were given amnesty in the 1930s. Public benefits were available to immigrants until the 1970s, and it was not until 1986 that it became illegal to hire an undocumented immigrant:

In sum, from the early 1900s through the 1960s, millions of predominantly white immigrants entered the country unlawfully, but faced virtually no threat of apprehension or deportation. Businesses lawfully employed these immigrants, who were eligible for public benefits when they fell on hard times.

Like their spiritual antecedents in the Klan, Donald Trump and his minions have mainstreamed racism and xenophobia despite the fact that some of them literally owe their lives to America's tradition of welcoming immigrants. Had the 1924 Act been in force when Stephen Miller's great-grandfather emigrated from Antopol (Belarus) in 1906, Miller might have never existed. All but 7 of the 2,000 Jews living in Antopol were murdered by the Nazis. See David S. Glosser, "Stephen Miller is an Immigration Hypocrite." *Politico*, August 13, 2018.

Government Services: Immigrants pay far more in taxes than they receive in benefits. Immigrants use government services at a **far lower rate** than native-born Americans despite paying taxes that support those services. Lawful permanent residents are not eligible for Medicaid, food stamps, or other "means-tested welfare benefits" until they have resided in the United States for five years, and they are ineligible for Social Security or Medicare until they have paid payroll taxes for 10 years. *Undocumented immigrants are never eligible for any of these programs.*

Jobs: Immigrants create more jobs than they take. They start businesses at much higher rates than native-born Americans and pay higher wages. And they often take those jobs few Americans would want—two of Trump's three wives were immigrants.

"Illegal" Immigration is no more common today than between 1900 and 1960. The difference is that the millions of predominantly white immigrants who entered illegally during that period faced no threat of being apprehended or deported.

Number of Immigrants. We are not being overrun by immigrants. Today, immigrants constitute 13.7% of the U.S. population, slightly below their historical rate between 1870 and 1930.

John Adams, prior to becoming one of our founding fathers and our second president, was a lawyer who defended the British soldiers charged with murdering American patriots in the Boston Massacre. He did so during a time of political upheaval and representing the soldiers was not popular. Adams said “it was, however, one of the most gallant, generous, manly and disinterested Actions of my whole Life, and one of the best Pieces of Service I ever rendered my Country.”

Those who attack and demean Public Defenders really attack and demean the “rule of law” and those in public office who do so also breach their oaths of office.

Is DeSantis Worse than Trump?

I'm not sure whether Ron DeSantis is actually a racist, but I am certain that he is something worse.

If he's not a racist, that is, if he is just throwing red meat to the wingnuts, then he's actually worse than a racist. Someone who promotes and exploits racism for electoral advantage is a lower form of life than a racist, at least IMHO. Andrew Gillum nailed it during one of the gubernatorial debates when he said, *"I'm not calling Mr. DeSantis a racist, I'm simply saying the racists believe he's a racist."*

Of course, that would only place DeSantis in a long and grotesque gallery of Republican miscreants who exploited racism to advance their careers. For example, early-stage Alzheimer's or not, Ronald Reagan had to understand full well the import of launching his 1980 campaign in the Mississippi county where Goodman, Schwerner, and Chaney were brutally murdered, and doing so with a speech appealing to States' Rights. It was a signal to the racists that he was with them. So too were his memes of "Cadillac-driving welfare queens" and "strapping bucks using Food Stamps to buy T-bone steaks.

Similarly, whether or not George H.W. Bush was a racist, he was happy to use the racist Willie Horton commercials as a stepping-stone to the White House in 1992.

Donald Trump is a different story. He is pretty much sui generis, or, as an unnamed general referred to him, "the most loathsome individual I have ever met." Trump exploited racism in his presidential campaigns but he also has a long history of actual racism, extending back to his twenties when he and his father Fred were sued by the Department of Justice (under Nixon!) for their refusal to rent apartments to Black applicants.

When he still owned casinos (that is, his before casinos filed for bankruptcy for the sixth and final time and he was bailed out by dark Russian money), casino bosses ordered the floor cleared of Blacks employees when they knew Trump was visiting. Most monstrous were his calls for executing the Central Park Five and his continued insistence on their guilt even after their convictions were vacated on DNA evidence.

My personal favorite was his mixing of antisemitism with racism when he complained about a Black accountant: "Black guys counting my money! I hate it. The only kind of people I want counting my money are short guys that wear yarmulkes every day. ... I think that the guy is lazy. And it's probably not his fault, because laziness is a trait in blacks. It really is, I believe that. It's not anything they can control."

Stereotyping a people is the alpha and omega of gutter racism, but the irony is that *Trump* is the one unable to control himself. And let's be charitable and say Trump is not entirely at fault for becoming the miserable excuse for a human being he's been his entire life. Having Fred Trump for a father while being lazy, dyslexic, and intellectually challenged and unaccomplished cannot have been easy.

This raises the question whether DeSantis is more dangerous than Donald Trump. DeSantis is able to complete a sentence without sounding like a buffoon and is intelligent and academically accomplished. He would be far more capable of disarming our craven, credulous, national media.

Think about that in November before you decide not to vote because the Democrat on the ballot was not your first choice. Think about President DeSantis.

Writing to local papers is a way to influence NPAs and give aid and information to Democrats. Here are some samples from DCDB members.

In the March 26 Miami Herald online story “Investment and immigration conference cancels DeSantis’ speech after objections raised,” I was struck by State Rep. David Borrero’s defense of Gov. Ron DeSantis’ stance on immigration.

Borrero said, “We want to live in communities that are safe and free from drugs, gangs and crime. We expect our politicians to protect us from the cartels, drugs and violence that we escaped.”

His suggestion that communities are being terrorized by immigrants is false. If any group is terrorizing communities, it comprises those born in the United States, as a study in the “Proceedings of the National Academy of Sciences” concluded: “Contrary to public perception, we observe considerably lower felony arrest rates among undocumented immigrants compared to legal immigrants and native-born U.S. citizens.”

According to the December 2020 study, “Comparing crime rates between undocumented immigrants, legal immigrants and native-born U.S. citizens in Texas,” American citizens committed crimes at higher rates than legal immigrants and shockingly higher rates than undocumented immigrants.

The study stated that, “Relative to undocumented immigrants, U.S.-born citizens are over two times more likely to be arrested for violent crimes, 2.5 times more likely to be arrested for drug crimes and over four times more likely to be arrested for property crimes.”

Of course, empirical evidence is a thin reed against the hurricane of emotion-laden disinformation in our post-fact world, so we should not expect to see either DeSantis or his minions changing their message.
