## A Psychologist's View

It's been a mystery to me. The phenomenon of Donald Trump. This man is as stupid as they come. Yet he is able to reach people and create passion for his ideas. How does he do that?

As a student of human behavior and cognition, I was drawn to the conversation on a recent CNN "Smerconish Show." The guest speaker was Scott Adams. You might know of him as the creator of the comic strip Dilbert. He said that he has studied hypnosis and persuasion his entire adult life. He was promoting his new book "Win Bigly: Persuasion in a World Where Facts Don't Matter." I already knew that Donald Trump was a master manipulator who used the techniques of persuasion with laser precision. Early on I saw that he was able to seduce a significant segment of the population. Like Scott Adams, I was one of the few who predicted (realistically feared?) Trump's triumph.

I agreed with Adams when he said that Trump is a master persuader who has been able to weaponize his skill set. Using well-known techniques, Trump is seemingly able to bypass the rational centers of the mind and hit directly at the (irrational) emotions. Hypnotists and psychologists have long been aware that decisions are rarely made entirely by our rational minds capable of thinking things through. More often decisions are made by our emotional centers that "feel" what's right.

I was unaware during the CNN interview that Adams was a Trump supporter. Because I had also understood Trump's persuasive powers before most other people, I didn't assume Adams was in Trump's camp. Then I read the book.

The book reads like a friendly tutorial on the techniques of persuasion, using Trump's words and actions as examples of how it's done. But I didn't have to read

past page 2 to get my first "What the Hell?" moment. Adams wrote, "I expected Trump to rip a hole in the fabric of reality so we could look through it to a deeper truth about the human experience. And he did exactly that."

Wait a minute! Yes, I believe that Trump bypasses our rational centers. I guess you could call that "ripping a hole" in the fabric of reality. But. A deeper truth?? No.

Outside the fabric of reality is emotion. Emotions which we experience and feel "as if" they are truth. Emotions create feelings which we can actually experience physically. These feelings seem real but the beliefs that accompany them are often distorted and destructive to the individual. This is the entire basis of cognitive therapy.

Following your emotions can lead you astray. Thoughts and beliefs unmoored to rational thought are fantasies, hopes and dreams. They may have their value, but they are not "true." They are made up. They are clouds that can easily solidify in the mind until we come to think they are as "real" as apples. But they are not.

I have spent over 30 years helping people to discover their irrational beliefs. Inevitably they feel freer and happier when their personal emotional experience is consistent with objective reality.

On page 19, Adams tells us that "Persuasion is all about the tools and techniques of changing people's minds, with or without facts and reason." This is true. What he does not mention is that persuasive techniques can be used to help people (as do psychotherapists) or to harm them (as did Jim Jones). Simply being persuasive does not make you "right" or "good" or "wise."

On pages 24 and 25, he says, “If you have ever tried to talk someone out of their political beliefs by providing facts, you know it doesn’t work. . . . facts are weak persuasion. If you’re using super strong persuasion, you can be wrong on the facts, and even the logic of your argument, and still win.”

Regrettably, I think we are all aware by now that this is very true for a significant segment of our population. Where Adams goes off track, in my opinion, is that he confuses being a successful persuader with being “right.” For example, on page 10, “When Trump’s critics accused him of laziness, ignorance, and cruel intentions, I saw a skilled persuader who knew what mattered and what didn’t. Apparently, he was more right than wrong on his priorities, because he won the election.”

As a psychotherapist, I also see Trump as a skilled persuader. But his only priority may be his own narcissism. If he is successful at persuading a large number of peo-

ple that he can speak directly to their fears, and hopes and that he has the power to save them from life’s pain, does that make him “right?” Or is he merely taking advantage of his superior persuasive skills to get what he wants for himself?

Yes. Trump is a successful persuader. But successful for whom? For the American people or for Donald Trump?

Since joining the Democratic Party a few months ago I have met so many wonderful people. What I have noticed is that Democrats are very good at creating well-reasoned, cogent arguments. It is great to meet such an intelligent, articulate, and rational group of people.

In a recent email to me, Michael Cantwell wrote, “All too often Democrats win the intellectual arguments but lose the emotional ones and thus [we] need to get better at reaching the gut as opposed to the brain.” I couldn’t agree with him more.

# Healthcare in Florida

Over the last nine months, we have watched Congress repeatedly attack the healthcare safety net. Financing access to healthcare is a confusing jumble of federal and state programs, and the Republican controlled Congress has used this to try and shred the safety net and hurt millions of people.

We Democrats oppose these efforts and we need to generate greater citizen support for initiatives aimed at improving access to affordable quality healthcare. We need to understand what programs Republicans in Washington and Tallahassee are promoting and attacking so we can effectively persuade our neighbors that voting for Democrats is voting for better healthcare.

Prior to the enactment of the Affordable Care Act (the ACA), Medicaid coverage was linked to federal cash assistance (welfare) programs that aided families with young children, people over 65 and people who were blind or disabled. In the 1990s, Congress expanded coverage for children by creating the Children's Health Insurance Program. CHIP allowed intact families with higher incomes and older children to qualify for Medicaid coverage.

This still left millions of our fellow citizens uninsured—as many as 48

million people. This is the hole in the safety net that the ACA was aimed at filling. First, the ACA changed Medicaid to cover everyone who earned less than 138% of the federal poverty level (Florida refused to expand Medicaid and still does not cover the poorest adults who are not in families with children, over 65, blind or disabled). Second, the ACA created the health insurance exchanges and helped pay the premiums for people who didn't qualify for Medicaid but who didn't earn enough to pay the full cost of insurance.

The national and state Republican dominated legislatures, now assisted by the Trump Administration, are working to destroy the safety net.

- Congress allowed CHIP funding to lapse as of September 30. Florida's CHIP program is the fourth largest CHIP program in America and covers as many as 340,000 children. Unless Congress acts, it is projected that Florida's CHIP program will run out of funds by January 2018. While there may be some federal funding available, the state budget assumed full federal funding. It is unclear what, if anything, our legislature can do or will do to plug this gap. What happens to

these children's healthcare?

- Trump has eliminated payments to insurance companies that help subsidize premiums—this will hurt working Floridians and Florida families. The uncertainty created by this Administration has already caused premiums for next year to dramatically increase.
- Shorten the open enrollment period for getting insurance, kill funding for navigators (the people hired to help people enroll in the programs best suited to their needs) and limit access to the government healthcare websites.
- Propose a tax plan that will cut \$1 billion from the Medicaid program and \$500 million from Medicare to provide tax cuts overwhelmingly benefitting the top 1% of taxpayers.

As Democrats, we understand how these Republican state and federal initiatives hurt our neighbors and many of the people we work with every day. We need to expose politicians who support these policies. We then need to urge our neighbors to vote for Democrats next November so that all Floridians can have access to predictable, affordable quality healthcare.

Round 1 was the Reagan tax cut, funded by steep hikes in the Social Security tax, that led to a tripling of the cumulative deficit during his administration and a quadrupling by the time Bush I left office. After increasing taxes on high earners in 1993, the Clinton administration not only presided over the creation of 23 million jobs (thus puncturing the myth that higher taxes kill jobs) but turned over three straight annual SURPLUSES to the hapless Bush II administration.

Round 2 were the 2001 and 2003 tax cuts passed under W, with the now-disgraced Ayn Rand acolyte Alan Greenspan cheerleading the raid on the U.S. Treasury by claiming that surpluses were “bad.” The cuts not only failed to create jobs (less than 400,000 private sector jobs were created during W’s two terms) but they helped double the deficit. The odious Dick Cheney infamously claimed that “Reagan proved that deficits don’t matter.” Actually he would have been right if he’d but added “when a Republican is in the White House.”

Despite monolithic opposition from Republicans, and phony shrieks from shills like Alan Simpson (who idiotically claimed that if we didn’t start slashing social spending we’d be like Greece by 2010), the Obama administration managed to arrange for health insurance for an additional 20 million Americans, while creating nearly 11 million private-sector jobs.

And now, like some loathsome monster in a horror film, they’re ba-ack with a tax plan under which the top 1% gets 20.6% of the benefits in 2018 and nearly 50% of the benefits in 2027 (and the top 0.1% get 10% of the total benefits in 2018 and 25% of the benefits in 2027).

To help pay for the breaks given to the rich and the obscenely rich, Republicans will eliminate tax credits and exemptions that benefit middle class families, such as deducting the interest on college loans or taxing tuition reductions for children of university employees. Indeed, one analysis of the House bill found that families with children will see their taxes increase once the bill is fully phased in. Another found that some 20 million taxpayers earning less than \$200,000 were pay higher taxes, with another 54 million of them receiving a “tax cut” amounting to all of \$100.

Not to mention exploding the deficit by \$1.7 trillion. Republicans claim that tax cuts will pay for themselves but only idiots and liars say that. But I repeat myself.

Some of the grifters behind the plan (like Trump) are only interested in the additional money they can steal from the public purse for themselves. Others (like McConnell and Greenspan) are prostitutes pleasuring the plutocrats who keep them in office. But for others (like Ryan), the rapacious plunder is just means to an end. The real goal is to Make America Broke Again so as to achieve their lifelong goal of destroying Social Security, Medicare, and Medicaid.

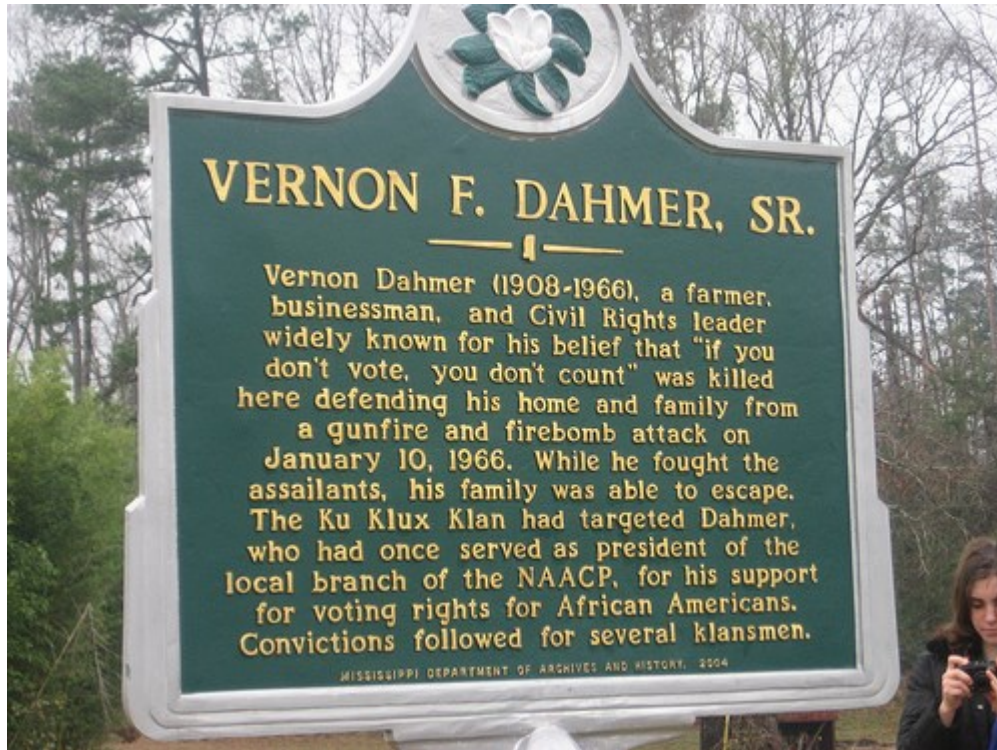
