Trump the Grifter, DeSantis the Opportunist

Given Donald Trump's precarious legal status headlining this issue, many Republicans are looking at Governor Ron DeSantis as the better choice for their party's presidential nomination. After all, he's more disciplined, appears more controlled, and he can complete a sentence.

But where it counts, the two share the same fatal flaw: A Messiah Complex. Remember Trump, looking at the sky: "I am the chosen <u>one</u>…"

And DeSantis' shameless "God Made a Fighter" ad, with a Morgan Freeman-like voice claiming DeSantis to be just what the Lord <u>ordered</u>.

And neither man holds fealty to any ethos or ethic.

"Trump's political party affiliation has changed numerous times. He registered as a Republican in Manhattan in 1987, switched to the Reform Party in 1999, the Democratic Party in 2001, and back to the Republican Party in <u>2009</u>.

"Trump in '04: 'I probably identify more as <u>Democrat</u>" headlined CNN.

DeSantis was always a Republican, but, like Trump, he governs by windmill, to the dominant political breeze. (Connecticut's former, twice-convicted, Republican Governor John Rowland did the same so often that cartoonists drew him wearing a beanie with a little propeller on top.)

Both Trump and DeSantis are anti-science. When Trump's panel of Covid-19 experts threw his ignorance into high relief, he discredited them and instead played Pin the Tail on the Virus, blindly stabbing at anything rumored to help, even when the scientists warned his recommendations were dangerous.

During the greatest public health crisis in our time, DeSantis governed according to Republican decibel levels. "Initially, as the virus began spreading in Florida, DeSantis had ordered a statewide lockdown, in accordance with Dr. Anthony Fauci's recommendations. Three weeks later, he changed his mind. 'We will never do any of these lockdowns again.' 'Any public distrust of this administration has been well-earned,' the Miami *Herald* editorial board wrote. 'We can't trust the governor with our lives.'"

DeSantis wouldn't tell us whether he'd been vaccinated. (Bet he had.)

Both men espouse a dangerous nationalism, the same kind of isolationist philosophy that kept the United States from entering World War II. This time, the world is inextricably interwoven.

Both are rabidly anti-immigration. Trump called Mexicans rapists and wanted a ban on Muslim immigration. DeSantis tricked asylum-seeking Venezuelans by offering them jobs in Florida, then inhumanely dropping them in Martha's Vineyard to prove he was tough on immigration, thus further afflicting the already afflicted.

Trump's racism runs so deep he's never stopped questioning President Obama's American citizenship, never let off accusing the Central Park Five, even after they were exonerated, never apologized for having called for their execution. DeSantis has made his opposition to teaching Critical Race Theory a religious calling, even though CRT is not and has never been taught in any public Florida school. He's purged the Florida school curriculum of all traces of true Black history and boasts about his war against "Wokeism" (which is no threat to anyone), threatening Florida teachers with felonies if they go a step beyond his censorship.

Warning: Color within the lines.

Both believe the law is what they decide it is. Trump tried everything to steal the election, by removing (Continued on page 3)

postal center mail sorters, eliminating drop boxes, and strongarming election officials to change their vote counts. DeSantis did all he could to disenfranchise Black and Brown people by restricting mail-in balloting, gerrymandering, even bragging at a press conference <u>held</u> in August, 2020, that the FL police arrested more than a dozen people of voting illegally in the election. (They didn't.)

Each refuses to oppose White Supremacists.

made good on that pledge – as of July 1, 2023, anyone who can legally own a gun in Florida will be able to carry a concealed gun in public without any training or background check. Floridians opposed the law by nearly a four-to-one margin (77% versus 21%) in a recent <u>poll</u>, but with a supermajority of his minions in the legislature, DeSantis governs by fiat.

Trump made it easier for people with outstanding arrest warrants to buy guns by eliminating nearly 500,000 names from the FBI's "fugitives from justice" <u>program</u>. And he rescinded a rule which

Any public distrust of this administration has been well-earned,' the Miami Herald editorial board wrote. 'We can't trust the governor with our <u>lives</u>.'"

Remember Trump to the Proud Boys after Charlottesville: "Stand back and stand <u>by</u>"? And when neo-Nazis in Orlando, FL waved flags and shouted antisemitic comments, DeSantis did nothing while his press secretary <u>tweeted</u> "Do we even know they're Nazis?"

While our other great public health crisis, slaughter by guns, is raging, DeSantis bragged that Florida will soon be a no-permit, open carry state. DeathSantis would have allowed the Social Security Administration to submit the names of individuals suffering from severe mental illness.

Of course, DeSantis is smarter than Trump (who isn't?) but academic knowledge is no substitute for wisdom or emotional intelligence or fidelity to the Constitution and our democratic values. Neither man can pass the test.

Now, DeSantis is threatening to impose new taxes and tolls on Disney. A person does not need to receive an education at Harvard Law School (as did DeSantis) to recognize that passing laws that target speakers whose message you don't like is a classic example of a First Amendment violation.

Florida taxpayers bear the cost of cleaning up the Disney blunders and defending lawsuits resulting from the racist, homophobic, and unconstitutional bills promoted and signed by DeSantis. A list of the latter includes but is not limited to the following:

Anti-riot (HB 1) – this infamous legislation, a major DeSantis priority as evidenced by its bill number, permits the conviction of anyone at a political protest where there is violence, even if they have nothing to do with the violence. The bill also targets nonviolent acts of civil disobedience, such as marching down streets or blocking traffic, popularized during the Civil Rights movement and immunizes anyone who runs over a protestor.

Federal judge Mark Walker held that the law was unconstitutionally vague and overbroad and issued an injunction. DeSantis appealed, but the appellate court has let the injunction stand pending input from the Florida Supreme Court as to what conduct is prohibited by the statute.

Ballot Initiatives (HB 921) impose a limit of \$3,000 in contributions from donors to a committee trying to gather signatures for a Florida ballot initiative. A preliminary injunction was issued and the legislature amended the law so that it applies only to contributions from out-of-state donors. The same federal court issued a permanent injunction against the revised law as violative of the First Amendment.

Redistricting (2B/2C): The decennial redistricting began with the Republican-dominated legislature preparing a map projected to give Republicans a 16-12 edge. DeSantis redrew the map to eliminate a minority district and extend the projected Republican advantage to 20-8. A circuit judge blocked the new map but was reversed, and the Florida Supreme Court refused to intervene, handing Republicans four of the five seats they needed to flip the House. DeSantis failed to have a parallel case dismissed in federal court and a trial will begin this September.

Constitutional Carry Measure (HB 543) allows concealed carry in public, with no permit or training required. It is certain to engender lawsuits. When

shamelessly sanctioning what Chief Justice Warren Burger characterized as "one of the greatest pieces of fraud, I repeat the word fraud, on the American people... that I have seen in my lifetime" (namely, the claim that the Second Amendment created a personal right to gun ownership), even Justice Antonin Scalia recognized that the Second Amendment does not confer an absolute right.

Curriculum Transparency (HB 1467) The bill requires teachers to ensure that all books available in their classrooms have been selected by a certified media specialist, which has led teachers to empty their classroom libraries. Although the bill itself does not expose teachers to a felony, school district leaders reminded teachers that a separate bill already provides that anyone providing reading material containing "explicit and detailed verbal descriptions or narrative accounts of sexual excitement, or sexual conduct and that is harmful to minors" is guilty of a third degree felony." It also sets a 12-year term limit for school board members. The Florida Education Association (Florida's largest teachers union), Florida Freedom to Read Project, and Families for Strong Public Schools have filed an administrative claim challenging the law.

Disney (HB 9B) To retaliate for criticism by Disney of his "Don't Say Gay" bill, DeSantis had his minions in the legislature dissolve the Reedy Creek Special District in which Disney had self-governed for over half a century. After he learned this would burden taxpayers with over \$1 billion in Disney debt, DeSantis ordered his minions to pass a law renaming the district and giving him the authority to appoint its board. The day before he did so, Disney held a public meeting at which it signed a contract with the old board that effectively neutered the new board.

DeSantis threatened Disney with various punitive actions, and Disney filed a federal lawsuit accusing DeSantis of a "relentless campaign to weaponize government power against Disney in retaliation for expressing a political viewpoint." The new board sued Disney in state court to have its agreement with the old board declared void. DeSantis has requested a 250% increase in his litigation budget. He'll get it and will need it. Florida taxpayers will be stuck with the bill.

Election Administration (SB 7066) This bill required returning citizens to pay all outstanding court costs and related legal obligations before regaining the right to register and vote, effectively neutering the impact of Amendment 4, passed in

2018, which would have automatically restored voting rights upon completion of sentence. The law was held to be an unconstitutional "poll tax" by a federal court, but the decision was reversed by the U.S. Court of Appeals for the Eleventh Circuit.

Election Laws (SB 90) includes restrictions on Vote -by-Mail drop boxes, requires election cycle (2-year) renewal of Vote-by-Mail requests, does not allow water or food to be distributed when voter lines are long and does not allow third parties to return more than two Vote-by-Mail ballots, all of which were intended to make it more difficult for an individual, especially a Democrat, to vote. The bill was opposed by the SOEs in all 67 of Florida's counties and held unconstitutional and enjoined by a federal court. The state appealed and the U.S. Court of Appeals for the Eleventh Circuit has stayed the lower court's opinion while the appeal is pending.

Immigration – Ban on sanctuary cities (SB 168), part of which was struck down as discriminatory and the fact that sanctuary cities were not specifically defined. The appellate court recently dismissed the lawsuit in its entirety.

Individual Freedom Act (HB 7) Promoted by DeSantis as the Stop-Woke bill, this law specifically prohibits teachers and employers from offering teaching or training that the State has condemned as "woke." It has spurred a series of lawsuit. In the first, a disparate group of plaintiffs sought a preliminary injunction. Judge Mark E. Walker, of the federal court for the Northern District of Florida denied the motion as to all of the plaintiffs with the exception of a university professor, as to whom he reserved judgment.

In other suits involving different groups of plaintiffs, Judge Walker granted preliminary injunctions to (1) employers and DEI consultants and (2) professors and students at Florida universities. In holding the law unconstitutional he observed that, "rather than combat 'woke' ideas with countervailing views in the 'marketplace of ideas,' the State has chosen to eliminate one side of the debate." The State has appealed, but the Court of Appeals for the Eleventh Circuit has allowed the preliminary injunction to stand pending its decision.

Parental Rights in Education (HB 1557/ SB 1834) "Don't say gay" bans discussions surrounding sexual orientation and gender identity in our schools. A suit was dismissed because the plaintiffs lacked "standing" (i.e., could not show how they were harmed by the bill) but subsequently refiled.

Reducing Fetal and Infant Mortality (HB 5) bans all abortions at 15 weeks and after, unless it's proven it will be dangerous or fatal to the mother or the fetus is proven to have a fatal abnormality. It includes no exceptions for incest or rape. This law is now pending at the FL Supreme Court.

The Heartbeat Protection Act (SB 300) further banning abortions at 6 weeks. The Senate passed it on 4/03/23, the House passed it 4/13/23 and DeSantis signed it at 11 PM on 4/13/23 as announced on Twitter. It will take effect only if HB 5 is upheld by the FL Supreme Court and then would likely garner more lawsuits as it's even more restrictive than HB 5.

Social Media Platforms (SB 7072) The Big Tech Law provided substantial fines to social media companies if they removed conservative ideas from their sites. A federal court granted a preliminary injunction, which was largely upheld by the U.S. Court of Appeals for the Eleventh Circuit.

DeSantis Fired *("indefinite suspension" per governor's office)* Andrew Warren, an elected Democratic prosecutor, in August of 2022 because Warren had said he wouldn't enforce the abortion restrictions and new gender rules. Warren sued and the firing was upheld by the federal district court. Warren has appealed to the U.S. Court of Appeals for the Eleventh Circuit.


Flying immigrants to Martha's Vineyard – In September 2022 the Florida governor flew two planes of some fifty immigrants from Texas to Florida to Martha's Vineyard, allocating \$12M from Florida's budget for this purpose to send immigrants to Democratic states. The class action suit filed by and for the affected immigrants is proceeding in Federal Court in Massachusetts.

Ironically, due to the way the immigrants were inhumanely manipulated, DeSantis probably helped them avoid deportation, as they may be able to apply for a U Visa (available to victims of fraud) and thus have the opportunity to apply for citizenship in a few years. Ron DeDoofus strikes again.

Bottom line. Florida taxpayers are bearing the cost of Florida Man's flagrantly unconstitutional laws and cheap political stunts.

We Don't Vote, We Lose

I have often ridiculed White working-class Republicans for voting against their economic interests.

But what about Democrats who vote against their economic interests by "not voting"? A recent <u>article</u> reported that Democratic turnout was only 49%; that is, more than 2.6 million registered Democrats did not cast ballots last November.

Some of them may have thought that they were sending a message to the Democratic leadership by "not voting," but they were effectively voting for DeSantis, Rubio, and the rest of wolf pack known as the modern Republican Party. As David Foster Wallace, pithily put in, "you either vote by voting, or you vote by staying home and tacitly doubling the value of some Diehard's vote."

If but half of the registered Democrats who failed to cast ballots had voted for Val Demings, she would have beaten Marco Rubio by some 100,000 votes. And if 1.6 million of the 2.6 million Democrats who stayed home had gone to the polls or voted by mail, Charlie Christ would have been our "once and future" governor. And rest assured, there would be no supermajority of Banana Republicans in Tallahassee passing unconstitutional and hateful laws while ignoring the insurance, housing, and healthcare crises plaguing the state.

In addition to self-styled progressives who flat-out refused to vote for Charlie Crist because he had been a Republican a decade earlier, only 42% of Black Democrats and 35% of Latinx Democrats cast ballots. I am a self-styled progressive, a member of what the late Paul Wellstone referred to as "the Democratic Wing of the Democratic Party," but I learned from 1980, 2000, and 2016. "Some babies," as Bob Dylan once sang, "never learn."

What progressives could have learned from each of those elections is the utter folly of staying home because you are disaffected with the Democratic candidate. Ronald Reagan replaced the New Deal with his Raw Deal and appointed Antonin Scalia, Sandra Day O'Connor, and Anthony Kennedy to the Supreme Court, three of the five "justices" who selected George W. Bush in 2000. Bush launched illegal wars, violated international human rights laws, doubled the deficit, and appointed the odious Sam Alito and the villainous hypocrite John Roberts to the Court, maintaining the 5-4 conservative majority (instead of a 6-3 liberal majority had Gore been in the White House).

Obama spent 8 years undoing only part of the damage done by Bush. I spent the 2016 election arguing with people like the imbecile who called Hillary a "psychopathic fascist." By refusing to vote for Clinton, they gave the real fascists the opportunity to seat trust-fund baby Neil Gorsuch, alleged rapist Brett Kavanaugh, and handmaiden Amy Coney Barrett. Let us hope that the answer to the refrain, "When will they ever learn," will be 2024.

As to the poor turnout around the other portion of the Democratic base, there is some truth to the claim that apathy and cynicism in minority communities is fueled by Democrats coming around every two years and asking for their vote without explaining why. But the fault lies on both sides.

One person interviewed in the Post article said she was "motivated to see Donald Trump not get reelected" in 2020 but she didn't feel as hostile toward DeSantis because "her main news sources — CNN, NPR, Reuters and Vox — didn't cover DeSantis daily." Had she picked up a copy of the *Palm Beach Post* or the *Sun-Sentinel even* occasionally, she would have learned enough about Mao DeSantis and his Cultural Devolution and De-Education Camps to never stop throwing up. That failure is on her, but the failure of the Democratic Party to educate her is on us.

Similarly incredible is the justification of the Gen Z voter who cast ballots in 2018 and 2020 but not in 2022 because, "The poll numbers showed that Florida was going to be decisively Republican in the presidential, governor and Senate elections so I didn't feel like it was worth taking time away from work." If but half of the registered Democrats who failed to cast ballots had voted for Val Demings, she would have beaten Marco Rubio by some 100,000 votes.

So hw do we reach these voters, and what do we tell them?

First, it's obvious that we need to get out more, but for those who cannot, there are phone banks. It's mindboggling that there are Democrats unaware that he could have voted without missing work if he voted by mail. And it's likely that hundreds of thousands Democrats who voted by mail in 2022 do not know that their VBM requests expired last December and they must reapply. I've had nothing but positive experiences, which I attribute in part to the fact that Republicans are slow readers, although that last comes with a note of caution. With the permitless carry law having been passed by DeSantis's minions, it's worth adding that "past performance in no guarantee of future results."

A Message from Congresswoman Lois Frankel About Medicaid

During the three years of Covid 19, Congress prohibited states from removing anyone from Medicaid. As of April 1, 2023 states are once again able to determine Medicaid eligibility. If you fail to update your information by April 30, 2023, you may lose your coverage starting May 1st.

To be eligible for Florida Medicaid you must:

- make less than \$19,392 as a single person household
- make less than \$26,228 as a household of 2
- make less than \$39,900 as a household of 4

You must be one of the following:

- pregnant
- blind
- responsible for a child under 18
- 65 years of age or older
- have a disability or a family member living with you who is disabled

Please call Congresswoman Frankel's local office at (561) 998-9045 if you have any questions,

Remember that all beneficiaries must be recertified and you will have to respond every 6 months to stay on the books. If you receive SNAP benefits you might have already been certified.

You can recertify by going on line to your DCF account. You should have received an envelope from DCF but make sure you fill out the form and return it to:
