### **An Extraordinary President and an Extraordinary Man** *Michael K. Cantwell*

Joe Biden has been the most effective president of my lifetime.

## **Rick Scott: One of the "Most Corrupt Politicians Running for Reelection"** June S. Neal

It's been 14 years since the 2010 Supreme Court decision in *Citizens United v. Federal Election Commission* "reversed century-old campaign finance restrictions and enabled corporations and other outside groups to spend unlimited funds on elections."

End Citizens United is a grassroots organization that's been fighting *Citizens United* and exposing political corruption ever since. Rick Scott tops their recently published list of "<u>Most</u> <u>Corrupt Candidates in 2024</u>."

Scott is a bland kind of guy. Postcard-flat affect. Stick-on smile. No memorable quotes. Although he served as Florida's governor from 2010 to 2018, and was elected its junior senator in 2018, whatever name recognition he has doesn't come from any leadership achievements. It's from scandal, conflicts of interest, and lies about protecting Medicare, Medicaid and Social Security.

But his banal mien serves him well, masking a cunning businessman who has made millions through symbiotic business/government investments. And with the use of his wife's convenient portfolio to create the illusion of "blind trusts."

Scott is very rich. But millions of other Americans live paycheck-to-paycheck and/or rely on Medicare, Medicaid, and Social Security. Scott calls these safety nets "socialism," either ignorant or deliberating choosing to misrepresent

the actual meaning of the term. Most likely, it's not ignorance. Scott is not stupid and attacking Democrats as socialists is effective scaremongering, Of course, as my colleague Michael Cantwell, noted in a previous article, <u>The Threat</u> <u>Isn't Socialism. It's Fascism</u>, "What Republicans call "socialism" is legislation that benefits ordinary Americans rather than the bank balances of the top 0.01 %." The company billed the government for tests doctors never ordered, for exaggerated diagnosis codes that brought greater reimbursement and for home health care for people not qualified to receive it.

HCA <u>admitted</u> "submitting inflated bills and expenses to the government; exaggerating the seriousness of diagnoses to increase Medicare reimbursement; illegally structuring business deals so that Medicare picked up the cost of corporate expenses; and providing doctors with kickbacks for patient <u>referrals</u>."

"The fraud at Rick Scott's company hurt seniors, it hurt taxpayers, it hurt everyone,' John Schilling, a former HCA accountant who worked with the FBI in 1996 through 2003, said at a 2014 press conference. 'Fraud was in the DNA of Rick Scott's company from the very beginning and he was the father.'"

Scott has never tried to help ordinary Americans. He voted against the Bipartisan Infrastructure Law, which is providing Florida with more than \$6 billion in federal funds to invest in roads, bridges, public transit, ports and airports. One of Scott's first acts as governor was to refuse \$2.4 billion in federal money for a high-speed train line. He later invested with his wife in a fund that has links to Brightline. a private company building a new high-speed rail line.

#### Multibillion Dollar Medicare/Medicaid Fraud

Scott's notoriety began with Columbia/HCA, a multimillion-dollar chain of for-profit-by-fraud hospitals that Scott, as CEO, grew into the biggest such chain in America.

Following a massive, multi-agency federal investigation, the company pled guilty to 14 felonies and paid the government a total of \$1.7 billion in fines and damages. At the time, it was the largest Medicare and Medicaid health care fraud case in U.S. History.

The company profited off the sick and injured by bribing doctors with all kinds of swag to send their patients, not to facilities that best met their needs but to Columbia/HCA hospitals that would overcharge Medicare, Medicaid and TRICARE, the military's health care program. Doctors were offered "free rent and office refurbishment and free drugs from hospital pharmacies. One of HCA's most controversial business practices involved providing partnership investments in company hospitals for doctors, who could then refer patients to them."

During a deposition in a separate but related case, Scott <u>pleaded the fifth 75 times.</u>

We don't know why Scott was never indicted. Of course, that could be because the government found no wrongdoing on his part. But Scott claims he wasn't even interviewed and that seems true. So, how was he eliminated from blame if he was never questioned?

Scott has dismissed the fraud investigation as old news but resurrected it recently in a press conference outside the Manhattan courthouse where Donald Trump was being tried (and later convicted) for 34 felonies. Perhaps seeing something to be gained by adopting Trump's phony victimization, he compared the HCA Medicare fraud to the charges against Trump. As the Miami Herald <u>reported</u>, he had earlier appeared on "Fox & Friends," where he bragged, "I fought Hillarycare, and guess what happened when I fought Hillarycare? Justice came after me and attacked me and my company."

*New York* Magazine responded to Scott's "outlandish" claim by observing that, "Many prominent people from both political parties opposed 'Hillarycare' and somehow didn't find themselves or their businesses under investigation for criminal fraud." It also noted "the little matter that the record fines imposed on Columbia/HCA were part of a settlement in which the company admitted all sorts of wrongdoing."

# "If only "somebody told me something was wrong."

Unbelievably, Scott claimed he would have stopped the fraud— if only "somebody told me something was wrong." Was he in a coma?

Three major federal agencies spent nine years on the massive case with the help of eight whistleblowers. One of them, John Schilling, a former HCA accountant who alerted the FBI and worked with them from 1996 through 2003 had a different view:

The fraud at Rick Scott's company hurt seniors, it hurt taxpayers, it hurt everyone . . . Fraud was in the DNA of Rick Scott's company from the very beginning and he was the father." Although the Justice Department's final settlement with the company was announced June 26, 2003, it noted that the fraud went decades: "HCA had systematically defrauded Medicare, Medicaid and other federally funded health care programs through schemes dating back to the late <u>1980s</u>."

Instead of being appalled by Scott, voters made him governor of Florida twice and then senator. He's the richest member of the US Senate. With serious conflicts of interest.

#### "Past Is Prologue"


Scott is running for a second term as senator, so a dive into his symbiotic business-political ventures is essential—and illuminating.

Scott's forced resignation from HCA came with a bespoke parachute of \$300 million in stock, \$5.1 million in severance pay, and a five-year, \$950,000-per-annum consulting contract. Scott has a talent for investing, and he used his good-bye bonanza to vastly multiply his personal wealth.

While still a private citizen, and despite his HCA scandal, Scott co-founded Solantic, a chain of walkin clinics in Northeast Florida that became the dominant group of emergency clinics in Florida.

In 2008, he decided to run for public office. He poured \$73 million into his campaign and barely beat Alex Sink. The ante was big, but he may have figured on even bigger rewards.

But he knew that serving as Florida's new governor come January 2011, he would have to answer growing accusations about conflicts of interest between his holdings and the state's business. So, just before he took office, he put his shares of Solantic into his wife's revocable trust. But critics charged that didn't qualify as the legally necessary "blind" trust because Scott could see the account.

On March 22, 2011, Scott signed an order mandating drug tests for all state employees, a profitable service Solantic could have performed, trust or not.

Then-Attorney General Bill McCollum's campaign questioned how a Scott administration would handle Solantic, which is regulated by the state Agency for Health Care Administration and hires doctors licensed by the Department of Health. Both agencies are run by the governor's <u>appointees</u>." So, in April of that year, Scott sold his <u>Solantic</u> stock to Welsh, Carson, Anderson & Stowe, a New York firm that already owned a 30% share of the company.

He continues to claim there is no conflict of interest concerning his vast investments and holdings. But his federal financial disclosure reveals, *Scott and his wife have millions of dollars invested in the same companies*. As <u>Politico</u> reported: Hundreds of investments are held simultaneously in both Scott's blind trust and by Ann Scott . . . There are numerous examples of official Scott administration actions that benefit more than just Ann Scott's investments, which Rick Scott could see while in office.

Since then, Scott was reelected as governor in 2014 and elected as Florida's junior senator in 2018. He spent \$73 million of his own <u>money</u> (nearly 86% of the total campaign funds!) for his first gubernatorial race in 2010, yet defeated Democrat Alex Sink by only 68,000 votes or 1.2%.

He contributed even more money in 2014 to compete against Democrat Charlie Crist with even less of a return—61,000 votes— just 1%. For his Senate run in 2018, despite another massive infusion of personal cash, the race against incumbent Democratic Senator Bill Nelson was so close it needed a squirt of WD40: <u>0.2 percent!</u>

He's currently the top, self-funded Republican candidate, donating more than <u>\$20 million</u>.

These are some of the reasons why groups like <u>End</u> <u>Citizens United</u> see red, and what Floridians should remember when voting come November is, "Who will truly serve the will of the people?"

### New Florida Laws: The Push Toward Evangelizing and Whitewashing Our Public Schools June S. Neal

Effective July 1, 2024, here is the good, the bad, and the truly ugly, such as the Republicans' obsession to turn Florida into a religious autocracy, particularly their attempts to evangelize our public schools. And their contempt for truth as they pretend racial bigotry and inequality never existed.

# **<u>HB 1291</u>**. Prohibits "Woke" in Teacher Training (Shameful)

"Florida is where WOKE comes to die," has been Governor DeSantis's oral bumper sticker. He promised to keep Woke, and the dreaded Critical Race Theory, out of our public schools. He even signed a <u>W.O.K.E. law</u> "Stop the Wrongs to Our Kids and Employees <u>Act</u>," Easy victory, since neither were taught here. And to ensure the phantom subjects don't find their way in, our teachers will be at the ready. Their new training "May not distort significant historical events or include a curriculum or instruction that teaches identity politics or that "systemic racism, sexism, oppression, and privilege [White] are inherent in the institutions of the United States."

As per DeSantis's many press releases and interviews, "distort" means that slavery, Reconstruction, Jim Crow, the internment of Japanese Americans, The Indian Removal Act, the decades of discrimination against Latinos and LGBTQ+ people just didn't happen.

**<u>HB</u>** 1285. "Classical Education" Teaching Certificates.

The State Board of Education will establish rules for those who wish to teach at a "classical" school, one that teaches the "development of moral character and civic virtue, the liberal arts and sciences...and is based on the classical trivium stages of grammar, logic, and rhetoric."

Teacher applicants are *exempt from "demonstrating mastery of both general and subject knowledge, professional preparation and education competence."* The exemptions caused teacher and Democratic Rep. Ashley Gantt of Miami-Dade County to question, "What measurement are we using to make sure that they're qualified [and]... adhering to whatever curriculum is developed and... actually have the ability to teach that?"

But accepting people without traditional education and experience has become a way for DeSantis to deal with Florida's severe teacher shortage, such as allowing veterans and retired firefighters without bachelor's degrees, and others with only two-year degrees, to teach with mentors. A 2023 study by the <u>Learning Policy Institute</u> showed Florida to have the lowest "teacher attractiveness" rating in the nation.

**HB 1285**. Limits the number of requests to **Ban Books** (Republicans call them "challenges"), by non -parents to one title per month. DeSantis accused "activist' teachers of making a 'mockery' of his parental rights legislation by filing frivolous challenges. Parents (like the lunatic Moms for Liberty) have no limits. <u>PEN America</u>, the writers' organization that's fighting book banning, reports that Florida is responsible for 72% of the books that have been pulled from the nation's schools in the first half of the current school year.

<u>SB 1264</u>. Schools Must Teach "the evils of Communism." "The truth will set us free," said DeSantis in a press release. (Yes, he really did.)

**HB 931.** Allows chaplains to counsel students in public schools. Beyond the frightening, antidemocratic melding of church and state, the law doesn't require the chaplains to demonstrate any credentials. In addition, some faiths condemn as sins suicide, homosexuality and abortion, issues that demand trained psychology or psychiatry professionals.

**HB** 1317 Patriotic Organizations Welcome in **Public Schools.** Specifically named are Big Brothers and Big Sisters of America, Boy Scouts. Girl Scouts,

Boys and Girls Clubs of America, Civil Air Patrol, Farmers of America, Little Leagues Baseball, Marine Corps League, and the Navy SEAL Cadet Corps. However, the schools don't have to allow in any groups that aren't designated "patriotic."

#### **Politics**

#### <u>HB 919</u>

Artificial Intelligence in Political Ads. Ads that depict real people person doing things that they never did must disclose the use of A.I. A violation can result in a first-degree misdemeanor charge. (Big deal. If the ad is full of lies, the damage is done.)

#### Health (good)

**HB 159. HIV prevention in pharmacies.** Florida is among the states with the highest number of new HIV cases in the country. Now, pharmacists can prescribe and dispense medicine to prevent HIV infection after exposure if taken within 72 hours.

#### HB 935 — Home Health Care Services

Home health services can now be paid by Medicaid if prescribed by advanced practice registered nurses or physician assistants.

#### And now, for some good stuff:

<u>SB 544</u> Free swimming lessons. Florida will offer swimming lessons at no cost to families with a household income of less than \$45,180 a year and who have at least one child who is four years of age or younger, according to the Swimming Lesson Voucher Program. <u>Florida has the highest rate of child-drowning deaths</u>, ages 1-4 and 0-9 in the nation.

**HB** 187 Anti-Semitism. Defines antisemitism as calling for the deaths of Jewish people, stereotyping them and Holocaust denial.

**<u>HB 1109</u>** - Jewish Day Schools and Preschools. Allows security funding, as recommended by professionals.

**<u>HB 1181</u>** Juvenile Justice. Sets out rules for dealing with minors with illegal possession of firearms.

Oh yes, you *can't* release balloons in the air HB 321 and you *can* shoot a bear if it attacks you. HB 87

#### Envy, Fear, and Clickbait

The engine that drove the frenzy to force Biden to step down was fueled by envy, fear, and the quest for clickbait. Biden has done more good with fewer votes to spare than any Democratic president of this or the last century.

That breeds envy from those in the Obama administration who mocked him when he was vicepresident and pushed him to drop out in 2016. It breeds fear in Republicans who don't want to see him finish the job.

#### Always Look on the Bright Side of Life

If you're forced to get your clickbait by reporting on the greatest threat to our Republic since the Civil War, you can be part of the struggle to save it instead of another media outlet monetizing our descent into neo-fascism.

#### **Projection as a Psychological and Political Tool**

It also provides additional funding for the IRS to pursue wealthy tax cheats, an <u>effort</u> that has yielded \$1 billion in back taxes due. If funding is continued, an estimated \$851 billion will be recovered by 2034.

The IRA also removes the Bush-era prohibition on Medicare negotiating drug prices with Big Pharma. As a result, the monthly cost for insulin is now capped at \$35.

Incredibly, Biden accomplished all that with a split Senate and a 5-vote majority in the House. And even after Democrats lost the House, he outplayed Republican speakers, something neither Bill Clinton nor Barack Obama managed when in office During budget impasses, Newt Gingrich shut down the government twice and John Boehner's inability to control the Tea Party led to a downgrade in the government's credit rating in 2011 and a government shutdown in 2013. Moreover, Biden even outplayed Mitch McConnell, securing passage of a modified Green New Deal when everyone thought it was dead.

Biden's age and experience made that possible even as it forced him from the race. I have no doubt of Kamala's ability to finish the job of rolling back Reagan's Raw Deal just as Reagan eviscerated FDR's New Deal. *Let's call it the Real Deal, because that is what Joe Biden is.* 

### Unfit: A Matched Pair Michael K. Cantwell

Donald Trump is an existential threat to our Republican form of government and our democracy. There is no question that he lost the 2020 election or that his claim it was stolen was a barefaced and brazen lie; there is even evidence that Trump knew it was a lie. More than 60 judges, including judges appointed by Trump, rejected lawsuits asserting that the election had been fraudulently stolen.

Thank you for your excellent editorial analysis of the Supreme Court's anti-democratic decision to remove the authority of the federal agencies to interpret the laws they administer and give that power to the courts. We can anticipate a similar attempt to eviscerate state agencies.

I served as the Director of Communications and Consumer Education for the Connecticut Department of Consumer Protection for 23 years. Our jurisdiction was broad, from u nfair trade practices to food and product safety. We knew our laws intimately. Thus, when faced with deadly collapsing baby cribs, Chinese pet food contaminated with melamine or an unregistered contractor scamming the elderly, we were able to act immediately.

We acted with the intent of the law — not as a politically driven court directive.

The justices and judges appointed by Donald Trump and Gov. DeSantis are replacing laws with their personal beliefs. The Supreme Court's Chevron decision effectively ends our system of checks and balances. Remember, justices: The Constitution created three separate, but equal, branches of government. **Re "Biden Made a Courageous Choice.** Democrats Must Seize the Opportunity" (editorial, July 22):

Thank you for one of the best assessments of today's presidential race: "Mr. Biden has now done what Mr. Trump never will: He has placed the national interest above his own pride and ambition."

I cried when President Biden released his poignant letter of resignation. Not just for the loss of his superb leadership, but because, despite the pain of incredible personal tragedies, he's remained a role model of selflessness and decency.

He took on the weight of the American presidency following the mess left by former President Donald Trump. Florida State Sen. Ana Maria Rodriguez's June 5 op-ed, "Florida GOP has a key climate fix: Take on China," seemed, at first, to reference the bill recently signed by Gov. Turns out, Rodriguez was referencing something less feckless if equally infantile, namely, blaming China. Since 1850, the United States has emitted 509 billion tons of carbon dioxide. This dwarfs the 284 billion tons emitted by China. Moreover, we are now responsible for more carbon emissions than China. The average Chinese contributes 10.1 tons of carbon pollution annually, compared with 17.6 tons for the average American. Rodriguez celebrates the progress America has made in reducing emissions but fails to acknowledge that these achievements have largely been the result of executive actions taken by Presidents Barack Obama and Biden. Ex-President Donald Trump rolled back more than 100 environment rules instituted by Obama and has pledged to do the same if re-elected. Perhaps the real climate fix would be to re-elect Biden and vote Republican climate-deniers out of office.

David Kurtz, <u>'Do Something' Is Not A Plan Or Wise Counsel Or A Way Out</u>, *Talking Points Memo*: "The greatest of these limitations is that much of political journalism is divorced from policy and the substance of politics. It's the horserace coverage, the who's up and who's down, the who's in and who's out. And no matter how complex the topic, or carefully balanced the various competing public interests are on a given issue, or how long the history of tackling the issue in a substantive way, once it enters the realm of political journalism it goes through a reductive process that distills it to whether it's good or bad politically. Does it help or does it hurt? And if it hurts, what are you going to do about it?

"Once you're in the lane occupied by political journalists, there are certain rules, customs, and expectations that subsume everything else. You're in our lane now and you're going to play by our rules. If all you know is politics, everything gets reduced to a craven political calculation. Actually, it's worse than that. If all you know is political journalism, then it gets reduced to the political journalist's projection of what politics is, what winning looks like, and who's losing under that particular contrived set of calculations."

Paul Krugman, <u>The Matrix of Consumer Discontent</u>, *The New York Times*: "What we see right away is that claims that Americans are much worse off than the official numbers say fail across the board. If consumers were really hurting on average, they wouldn't be spending so freely. They wouldn't be telling pollsters that their personal finances were in good shape. They wouldn't be upbeat about their own state's economy. And if things were really bad, you'd expect them to be bad for Democrats as well as for Republicans."
